Subject: Warden Message – New Bolivian Immigration Fees

Below are unofficial translations of sections of the Ministerial Resolutions No. 032/2008 and 047/2008, issued on April 24, 2008 and June 30, 2008 by the Ministry of Government of Bolivia and received by the U.S. Embassy on July 3, 2008. Through these Ministerial Resolutions the Government of Bolivia authorizes the adjustment of the current forms subject to fees which are used for administrative procedures at the National Immigration Service (SENAMIG), and approves a new schedule of fines applicable to aliens and nationals.

Please note that the new fee for the Tourist Visa for American Citizens is **One Hundred and Thirty Five Dollars (\$135.00)**.

**Ministerial Resolution No. 047/2008**

**La Paz, April 24, 2008**

*(This translation does not include the justificatory section of the Ministerial Resolution.)*

**THEREFORE:**

The Ministry of Government, in compliance with its legitimate and specific attributions provided by law,

**RESOLVES:**

**FIRST:** To approve a new schedule of fines applicable to aliens and nationals, according to the following parameters:

- a) Foreign students who are studying in universities, institutes of any level, whose migratory status is irregular or whose temporary residency is due, will be sanctioned with a fine of Bs.7 (seven Bolivianos 00/100) per each day of irregular status.

- b) Aliens who within 24 hours upon the due date of their approved permanence in the country, stay in the national territory without having obtained an extension of their legal permanence, will be sanctioned with a fine of Bs.14 (fourteen Bolivianos 00/100) per day, to be computed from the next day after the expiration of their legal permanence.
- c) Foreign citizens and students who are studying in any educational institution in the national territory who did not obtain or renew the foreign citizen ID card within 25 work days upon the issuance of the student, temporary residency, or permanent residency visa, will be sanctioned with a fine of Bs.7 (seven Bolivianos 00/100) per each day of irregular status, to be computed from the date of their registration in their educational institution.
- d) Foreign citizens that circumvent migratory controls at airports, ground border crossing points, and other similar entry/exit control points will be sanctioned with a fine of Bs.280 (two hundred eighty Bolivianos 00/100).
- e) National citizens that circumvent migratory controls at airports, ground border crossing points, and other similar entry/exit control points during their entry into or exit from the country will be sanctioned with a fine of Bs.140 (one hundred forty Bolivianos 00/100).
